#### **TERMS & CONDITIONS**

#### 1. Payment:

- i) 100% advance at the time of booking.
- ii) Dues if any for any other service/ facility are to be cleared before leaving the premises.
- iii) Cheque/s to be drawn in favor of "TWENTY ONE CENTURY SHOOTING FACILITY PRIVATE LIMITED"
- iv) Service Tax as applicable.
- v) Extra cost of Rs. 2000 per hour will be charged if you extend your prefixed timing of shooting.

#### 2. Timing:

i) Timing will be calculated from the time crew members enter the premises, until wrap up.

### 3. Security Deposit:

- i) For booking which are for 10 days or lesser = Rs. 15000.00
- ii) For booking which are more than 10 days = Rs. 25000.00
- iii) The Security Deposit is a refundable deposit, and is subject to be refunded after all necessary deductions (if any), towards any damages/claims to the studio property.

### 4. Cancellation charges:

- i) 5% of booking amount If notice is given before 2 months from commencement date.
- ii) 20% of booking amount If notice is given between 30 days to 60 days from commencement date.
- iii) 40% of booking amount If notice is given between 7 days to 29 days from commencement date.
- iv) 100% of booking amount If notice is given within 7 days from commencement date.

#### 5. House Keeping:

- i) Chewing of tobacco / Gutkha / PAN or smoking etc inside the premises (covered or open areas) are strictly prohibited & are punishable under law. A spot-fine/penalty will be charged @ Rs. 5000.00 for any misuse/ misconduct.
- ii) Cleaning charges will be Rs. 1000/- day + Taxes (Payable Extra)

#### 6. Special Terms & conditions:

- i) No subletting of shooting floor or any allied area is allowed
- ii) The studio shall be kept in proper condition. All Civil, Electrical, Sanitary, Plumbing, Drains, Sewers, Furniture & Fixtures will be maintained by the client in proper condition. Any damage of whatsoever nature will be subject to Charge/penalty.
- iii) In case of any fire set up in the floor (without prior Intimation/ Confirmation) a Penalty will be levied as suggested by The Management.
- iv.) For operations at the studio all licenses and permissions of any kind to be obtained by the clients directly. 21st Century Studio shall not be responsible for the breach of any license and permit requirements.
